This contract uses the Association of Consulting Engineers Professional Services agreement 2019 and the terms of the attached Engagement Agreement.

In accordance with Health and Safety Executive legislation, specifically - the Construction,

The services required are detailed by ✓and will be charged at the rates set in the standard schedules below. The normal, 'full, all inclusive, Project Consultancy service' is charged as a percentage of the value of the final project costs or by negotiation – schedule 1 + travel expenses at 45ppm.

Assessments etc. are charged on a daily rate schedule 3.

Notes on full service

Appointment is fulfilled by the client signing this form. No projects will be notifiable to HSE as all will be complete within 500 man days. Preliminary designs and site visits are normally charged in accordance with Schedule 3. In some circumstances the cost of an initial site report can be absorbed in the fee if the appointment for a new bridge is made immediately after the preliminary report. When the full service is being provided there will be an option to charge stage payments of fees after the design stage (usually 75%) and the balance after the construction and certification stage. Abortive work will be charged in accordance with Schedule 3. There will be no lone working. Geoff Freedman will have a 'buddy' on all site visits. There will be regular telephone updates if driving alone.
